



Roseville Girls Softball Thunder All-Stars Contract - 2026 Season

The terms and conditions of this contract serve to ensure the Roseville Thunder All-Stars Softball/ Roseville Girls Softball (RGS) program will be an educational, physical, and competitive program of growth for all who participate. The terms and conditions shall be agreed upon and followed by the Roseville Thunder All-Stars Softball Program, the coach, the player, and the player's parents or legal guardians. To ensure the value of Sportsmanship, all members of Roseville Thunder All-Stars Softball program, including the team coach, the player, and the player's parents or legal guardians shall execute this contract.

Roseville Thunder All-Stars is an All-Star team as defined by USA Softball of Sacramento's All-Stars Program guidelines. This program is affiliated with the RGS youth recreation program. Unlike the RGS recreational program, players are not guaranteed minimum playing time; however, the coaches will, in exercising their discretion, make various decisions which will provide for playing opportunities as they see fit. Playing time will be determined by several factors, including but not limited to, the coach's assessment of ability, game performance, attendance, practice performance, attitude, and dedication.

The Roseville Thunder All-Stars season begins mid-May and concludes after USA Softball Nationals and the California State Games in late July or early August. Players entering in this contract are committing to the full season of play with their All-Stars team.

Code of Conduct

Parents, players, coaches and all those affiliated with the parent, player and coach shall abide by the Roseville Girls Softball's Bylaws & Operating Policy. By signing this document, you acknowledge that you have read and are familiar with all such documentation.

Eligibility

Roseville Thunder All-Stars players shall follow all USA Softball of Sacramento's eligibility guidelines and shall not practice, play, or workout with any other softball team during the All-Stars season, other than their assigned RGS recreational league team. The team may only participate in USA Softball sanctioned events. Failure to comply with the RGS Bylaws/Operating Policy or Eligibility Guidelines may lead to player termination from the Roseville Thunder All-Stars team.

All players must submit medical release forms, copies of birth certificates, contracts or other documents requested to be completed.

Schedule

The practice and tournament schedule is set by the Coach.

Family Financial Investment

Roseville Thunder All-Stars player fees for the season will be \$550.00. Fees include:

- Partial Uniforms (Game and Practice jerseys, sweatshirt, socks, helmet decal, visor)
- Allocation towards All-Stars team discretionary funds (\$75)

- Tournament Entry Fees (3 Summer tournaments)
- League-associated expenses (fields, chalk, lights, insurance, etc.)
- Team supplies (first aid kits, etc.)
- Team equipment (catcher gear, etc.)

Player fees are due on or before their due dates.

Payment of player fees may be made (1) in full or (2) on the following schedule:

- At Registration Payment 1 \$325
- June 15 Payment 2 \$225

Player fees are due on or before their due dates. Parents/Players are responsible to pay bank fees on any checks that are returned to the Organization. It is each family's obligation to meet their portion of this financial commitment on a timely basis. Failure to meet the financial obligation by the payment due date will result in the player being declared inactive to participate in practices, tournaments, or other functions until the obligations are brought current. Ongoing failure to bring the player's account current (absent relief granted by the Board of Directors based on unique hardship) shall result in the player's dismissal from the team and the player's delinquent status being reported to USA Softball. Further, RGS in its discretion reserves the right to file a Small Claims action in order to recover all amounts not paid.

No refunds will be issued if a player leaves the team prior to the end of the season, for any reason.

Fundraising and Sponsorship

Each team is also required to secure one \$400 sponsorship to supplement the cost the league incurs to operate the Thunder All-Stars Program.

The team must follow all Fundraising and Sponsorship policies as outlined in the RGS Operating Policy. The Manager is responsible to account for and submit all fundraising / sponsorship monies to the RGS Treasurer or an Executive Board Member and must work with the RGS Sponsorship Coordinator when securing sponsorships.

Except for the required \$400 team sponsorship, fundraising money will be at the team's discretion, as approved by the Board of Directors. All fundraising monies will be equally distributed amongst all players on the team. No individual fundraising allowed.

Communication and Dispute Resolution

Following the RGS code of conduct, parents are expected to adhere to a 24-hour "cooling down period" prior to discussing player issues with the team coach. Concerns will be managed in a professional environment taking into consideration and insight from the perspective of the parent(s), the player's, and the coaches. The Roseville Thunder All-Stars Staff will discuss issues related to concerns and make decisions which are in the best interest of the team, athletes, and coaches. Violation of the above policies will not be tolerated and will result in the player's removal from all Roseville Thunder All-Stars functions, including practices, games, and other activities.

Consent to Play

I give my permission for my child, _____ to represent the Roseville Thunder All-Stars and RGS, a competitive fastpitch softball team, and to accompany her team to any of its local or out of town tournaments, games, practices, activities and/or events.

In the event my child is injured or becomes ill during any playing or non-playing activities of Roseville Thunder All-Stars I hereby authorize her coach or any other official of Roseville Thunder All-Stars/RGS to administer or obtain appropriate first aid and, if necessary, to transport my child to a physician or hospital for further treatment.

I hereby consent to my child's participation in any and all activities and/or events of the Roseville Thunder All-Stars/ RGS, and I agree to release, indemnify and hold harmless the Roseville Thunder All-Stars/ RGS, and its officers, directors and agents, from and against any liability of any kind arising out of the activities of the Roseville Thunder All-Stars/RGS or transportation to and from such activities.

I understand that the medical insurance provided by the Roseville Thunder All-Stars/RGS Organization affords only excess or secondary coverage which would apply only after other medical insurance providing coverage for my child has been resorted to. I further understand that the coverage provided by the Roseville Thunder All-Stars/RGS may have a deductible amount.

I understand that participation in competitive athletics involves risk of physical injury or death which cannot be totally eliminated. However, players may reduce such risk by following a proper conditioning program, wearing or using helmets and other appropriate safety equipment, and properly reporting any injury to their coaches. In allowing my child to participate in the activities and/or events of the Roseville Thunder All-Stars/ RGS Organization, I understand that we are expressly assuming the risks referred to above and releasing the Roseville Thunder All-Stars/ RGS Organization from any and all liability arising out of or in any related to the activities giving rise to such risks.

In participation with Roseville Thunder All-Stars/RGS, we agree to the above terms and conditions for participation as members of the Roseville Thunder All-Stars/RGS.
